Purpose

To provide assistance to member Associations to offset costs related to improving the administrative costs of the sport.

Criteria

1. This grant is available to the following AFSS Provincial Associations:

 - Alberta Frontier Shootists Society
 - Alberta Handgun Association
 - Alberta International Skeet Shooting Association
 - Alberta International Trapshooting Association
 - Alberta Metallic Silhouette Association
 - Alberta Full Bore Provincial Rifle Association
 - Alberta Sporting Clays Association
 - Alberta Smallbore Rifle Association
 - Alberta Skeet Shooting Association
 - International Practical Shooting Confederation – Alberta

2. Original Receipts are required for the Administration Grant ONLY (no photo copies, debit/credit card vouchers or cancelled cheques). Please keep copies of receipts for your records.

Restrictions

1. Purchases will not be reimbursed to an **individual**. All cheques issued will be made directly to the vendor or the member Association upon presentation of receipt by the Alberta Federation of Shooting Sports.
2. Associations may only receive one Administration Grant per calendar year.
3. All shooting equipment purchased remains the property of the Alberta Federation of Shooting Sports until AFSS policy determines otherwise.

Eligibility

To be eligible for funding the association must:

1. Be current members in good standing with the Alberta Federation of Shooting Sports.
2. Provide a breakdown of membership according to age.
3. Explain the program/event related to this request.
4. Applications will be accepted and reviewed throughout the year.
5. Decisions will be made 30 days following the initial submission.

How to Apply

1. Fill out Part D with original receipts
2. Fill out Part B with detailed explanations on how monies were spent
3. Submit Part D + Part B to AFSS office by December 1, 2021
